## **PRIVACY POLICY**

We are committed to protecting the privacy of all members and guests (and others associated with ECKANKAR in Australia in any way) where ECKANKAR has such an obligation.

ECKANKAR Australia (EA), and the Four Affiliates: ECKANKAR Society of Northern Australia (ESNA), ECKANKAR Society of Central Australia (ESCA), ECKANKAR Society of Southern Australia (ESSA), and ECKANKAR Society of Western Australia (ESWA) here after known as EA and its Four Affiliates, respect your right to privacy in relation to any personal information which they may hold.

EA and its Four Affiliates are aware of Australia's mandatory data breach reporting laws that came into effect on **22 February 2018**. Known as the Notifiable Data Breaches (NDB) scheme, it was passed as an amendment to the federal *Privacy Act 1988*.

#### Your personal information


These web sites may provide the option to sign up for newsletters, email groups, event registrations etc., and collect the following data:


